Course Description

SPAN 202 stresses the development of oral and written Spanish proficiency through a detailed study of grammar in authentic plays. Grammar concepts include but are not limited to interrogative words, personal pronouns, present tense verb conjugations, and agreement between nouns and adjectives. The course includes theoretical terminology and practical applications.

- 1) A 5 or higher on the STAMP assessment with no one domain below a 4 <u>OR</u> a 4 or higher on the AP exam.
- 2) High School GPA 3.0 or higher

Journal

You will write in your Spanish journal on the days you are assigned reading from *Ele de Teatro*. On journal writing days you will

- Read the play silently
- Read the play out loud in a group
- Complete the journal entry

Each journal entry should include

- 150+ word summary of what you read
- 150+ word personal connection to what you read
- A list of examples that demonstrate the assigned grammatical concept/s

After you have completed your journal entry

- Ask Chatgpt ¿Corriges mi español?.
 - o Copy and paste the first paragraph into ChatGPT.
 - O Copy and paste the revised version in your journal.
 - Highlight all the changes ChatGPT made.
- Repeat for the second half of your journal.

Journals are graded on completion and corrections. You earn full credit when you complete all the instructions. Journals are due on Blackboard at the end of your LLC time.

Grammar activities



All grammar activites allow you to apply the grammar concepts talked about in the previous class and prepare for the next class. After referring to the syllabus to find the assigned grammar activities,

- i. review your notes and /or book readings from the previous class,
- ii. complete the assigned grammar activities,
- iii. correct your work in a different color.

Homework is graded on professionalism, completion, and self-correction. Full credit is earned by professionally completing **and** self-correcting **all** sections in a color different from the completion color. See formatting options at the end of the syllabus. Homework will be collected and recorded on the day of each test.



Timed quizzes: 90-second quizzes

90-second quizzes allow you to demonstrate your mastery of written verb conjugations. You may take the quizzes as many times as you like but will only earn credit when you earn 93% or higher. Although I may remind you to retake the quizzes, ultimately, it is your responsibility to request to retake quizzes. You may only retake each quiz once a day.

Timed quizzes: 60-second talking quizzes

60-second quizzes allow you to demonstrate your mastery of oral verb conjugations. 60-second quizzes are unannounced. You will randomly draw verbs and conjugate them in the indicated forms. To earn full credit, you must correctly conjugate the verb in a short sentence. Please focus on standard grammar use and not on fluency.



Tests



Aside from the timed quizzes, this course includes section tests. You will take three written tests that focus on the most recent reading and grammatical material; however, previously covered material, especially grammar concepts, will often appear on the tests due to the nature of languages. There will be a comprehensive final examen. Please note that final exams will be given on the assigned Winthrop exam day which will differ from the regular assigned class time.

Use of Artificial Intelligence

Online tools and programs may assist you as a language learner, however, they are not a replacement for your creativity, originality, nor critical thinking. Tools such as https://www.wordreference.com/es/, https://www.linguee.com/,

https://www.spanishdict.com/ can increase vocabulary and grammar accuracy. AI programs such as ChatGPT and Google Translate can help offer suggestions on your already written work. Remember suggestions may be inaccurate, over / under representative of your abilities, or otherwise problematic. All work generated by an online tool or AI program must be cited. Since dictionary work is expected, any work turned in without any citations will be returned ungraded. Any plagiarism or other form of cheating will be dealt with under relevant Winthrop University Policies.

Course Credit

SPAN 202: Intermediate Spanish II is an AP-weighted, dual credit accrual course. Students earn one Carnegie unit of high school credit and three hours of transferable college credit upon successful completion of the course.

Students at Rock Hill High School receive college credit through Winthrop University. Students complete the Pre-College Application to be registered for the course and will receive a college ID. The course is a three-hour (credit) course and *may* be transferred to a college or university either in S.C. or out-of-state. Each college and university has a different protocol for how they will determine how many credits will transfer as well as whether they will count toward your major or general education requirements. Please call your prospective school's advising office for more information on not just whether your Winthrop University language credit will transfer, but also how the credits will be measured and translated for your specific major.

LIFE Scholarship

Grades earned in a high school dual credit course may affect scholarship eligibility. The LIFE Scholarship is a renewable scholarship for residents of South Carolina who are enrolled in college full-time. Awards are made automatically; no scholarship application is required. The amount is \$5,000 per year and may be "enhanced" to \$7,500 per year for upperclassmen in declared science and mathematics related majors. It is important to note to continue a LFE scholarship in the sophomore year, any credit hours earned before high school graduation will be used toward the student's cumulative GPA. Students must earn a minimum cumulative LIFE GPA of at least a 3.0 on a 4.0 scale. The LIFE GPA must include all grades earned at the college plus all grades attempted (excluding remedial) at all other institutions, both in-state and out-of-state.

Transcript

To be accepted as dual credit, the college course taken for dual credit must be approved by Rock Hill Schools. Approved dual credit courses within the Dual Language Immersion Program do not require preapproval. All other dual credit courses require specific permission from the district in order to be completed. Students should see their high school guidance counselors for appropriate permission forms and/or guidance.

While enrolled in a dual credit course, students are completing coursework as a member of the district and as part of their regular high school course loads. Grades earned in dual credit courses must be submitted to the district and counted as part of the student's GPA and ranking, even if a low or failing grade is earned.

Note that a dual credit course carries one additional quality points in calculation of the student's cumulative GPA.

FERPA

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students."

- Eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies.
- Eligible students have the right to request that a school correct record which they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent or eligible student has the right to place a statement with the record setting forth his or her view about the contested information.
- Generally, schools must have written permission from the eligible student in order to release any
 information from a student's education record. However, FERPA allows schools to disclose those
 records, without consent, to the following parties or under the following conditions (34 CFR §
 99.31):
 - School officials with legitimate educational interest;
 - Other schools to which a student is transferring;
 - o Specified officials for audit or evaluation purposes;
 - o Appropriate parties in connection with financial aid to a student;
 - Organizations conducting certain studies for or on behalf of the school;
 - Accrediting organizations
 - o To comply with a judicial order or lawfully issued subpoena;
 - o Appropriate officials in cases of health and safety emergencies; and
 - o State and local authorities, within a juvenile justice system, pursuant to specific State law.
