- A. CAEP = Council for the Accreditation of Educator Preparation
- B. All Winthrop educator preparation programs are accredited by CAEP – PK-12; undergraduate; and advanced degrees in educational leadership.
- C. CAEP Review Timeline:
 - Spring 2026 – CESHS submits self-study.

- Fall 2026 - CAEP Visit
 - Spring 2027 - Receive CAEP report.
