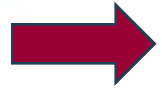
- If funds remain, we will do a second call with a deadline of September 15.

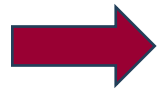

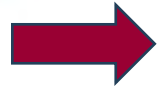

Professional Development Travel Requests

- ➔ You do not need to commit to purchasing hotel and flight, simply take a screenshot of your options and include it in your application. Once Funds are allocated to you, you can confirm arrangements.
- ➔ We anticipate making decisions by July 1, or as soon as the budget is received.
- ➔ In the case that we have more applications than funding, like this year, we may place a cap of available funds for each applicant.
- ➔ Networking at conferences is essential, particularly for junior faculty. However, when funding is limited, priority may be given to those presenting a performance, exhibition, or paper. Our goal is to support your research agenda and help you meet key milestones for promotion and tenure. Funding decisions may be based on faculty members' advancement needs.

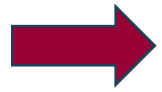

Edit Program

BA MUSIC TECHNOLOGY

After the NASM accreditation site visit, the visitors expressed a concern that the BA-Music with a concentration in Music Technology did not have sufficient ensemble hours to meet the standard of:

- (1) Ability in performing areas at levels consistent with the goals and objectives of the degree.
- (2) Understanding of procedures for realizing a variety of musical styles.
- (3) Knowledge and/or skills in one or more areas of music beyond basic musicianship appropriate to the individual's needs and interests, and consistent with the purposes of the degree."

This change is in response to our music accreditation site visit from NASM. The concerns are as follows:

1. There is a standard for accreditation for all Music Performance graduates to have knowledge of applicable solo and ensemble literature; and orientation to and experience with the fundamentals of pedagogy.

2. Courses are included as options, such as "voice majors must include MUST 319" or "piano majors must include MUST 510 and 520," however, these course number references do not include course titles, thus making it unclear what the course content might be.

MUST 101 Basic Musicianship

Edit Course

This course is required for the Musical Theatre Concentration of the Bachelor of Arts degree offered in the Department of Theatre and Dance. In the current configuration (2 credits; meeting twice a week for fifty minutes each class), students do not receive adequate time to learn the material. This course is paired with Basic Aural Skills (MUST 103, 1 credit), which provides the hands-on performative aspect of the material simultaneously with MUST 101. Taking MUST 101 and MUST 103 as separate courses puts the students at a disadvantage. It is "Course goals added. This course is now required in Tech/Design concentration curriculum. Course description modified to distinguish better from THRT 395." to a modern language class with no speaking component.

Rather than taking two separate courses (MUST 101 and 103), this proposal seeks to combine those courses into one 3-credit course that combines abstract music theory with the experiential learning model of aural skills. The course should meet on a 3-day schedule (MWF for fifty minutes each class) to maximize student engagement and retention of the material. Because the majority of Musical Theatre majors are singers, learning aural skills along with theoretical concepts will relate abstract concepts to their familiar art form. Daniel Gordon, chair of the Department of Theatre and Dance, supports this proposal.

It should be noted that music courses with the term "musicianship" in the title often refer to the study of aural skills (ear training, sight-singing, melodic dictation, etc.), so retaining the title of MUST 101 (Basic Musicianship) is appropriate for an expanded version of the course.

MUST 592 Internship I	Inactivate Course	The College of Education, Sport, and Human Sciences has changed the course for Internship II from MUST 592 to EDCO 690. The MAT program was the only program that required MUST 592, so it is no longer needed.

This course would address those deficiencies.

It is beneficial for actors, technicians, and those in managerial positions as well as Theatre educators since it touches on procedure, paperwork, organizational hierarchy, and baseline skills that will impact all of those groups.
