- A. CVPA Faculty Advisory Committee Report
 - 1. Revised wording for the CVPA Personnel Committee description (CVPA Bylaws) Laura Gardner handout
 - a. **CVPA Personnel Committee** Proposed Wording

The committee shall consist of five faculty members, including at least one member elected by each department (Design, Fine Arts, Theatre & Dance, Music) and one member elected

by the Faculty Assembly, and shall elect its own chair. Membership shall be limited to faculty members holding tenure. No one in an administrative position (including department chairs) may serve on the CVPA Personnel Committee. If a department does

not have any eligible members available to represent their department on the CVPA Personnel Committee then the vacancy shall become a CVPA at-large position for the remainder of term. Term of office shall be two years. Terms shall be staggered.

b. <u>CVPA Personnel Committee</u> – Current Wording

The committee shall consist of five faculty members, including at least one member elected by each department (Design, Fine Arts, Theatre & Dance, Music) and one member elected by the Faculty Assembly, and shall elect its own chair. Membership shall be limited to faculty members holding tenure. Term of office shall be two years. Terms shall be staggered.

2. Discussion

- a. What do you mean by administrators? Those who are supervisors; comment on annual reports; or are privy to info?
- b. Associate Dean is in the position to influence Chairs or Dean
- c. Who are we trying to exclude?
- d. Faculty member who is serving as an interim Chair within or outside CVPA?
- e. Only allowed to be on 1 personnel committee (either Department, College, or University)?
- f. Double-jeopardy situation.
- g. Husbands and wives on same committee... or 2 different personnel committees?
- h. Once it gets to the University Personnel Committee level the committee member is acting as the CVPA representative and represents CVPA and not personal agendas.
- i. No one should serve on more than one personal committee in a perfect world. But, this is not always possible. Usually problems are between department and CVPA committees. We should really avoid having someone on the Department Personnel and the CVPA Personnel Committees.
- j. Dr. Burmeister is not sure if we have the ability to make the decision that if a faculty member is serving on a departmental or CVPA personnel committee that they cannot serve on the university-personnel committee.
- k. Best for all concerned not to have 2 people (friend or foe) on 2 personnel committees.
- I. This is why we take these steps so we have an independent, un-biased committees.
- m. Administrative positions covers chairs, deans, associate chairs, and associate dean.
- n. Possible wording: Membership shall be limited to faculty members holding tenure who do not hold any administrative position, duties, or responsibilities.
 - i. Some people hold administrative positions but aren't administrators.
 - ii. Easier to list Deans, Associate Deans, Chairs, and Associate Chairs?
