SCOPE OF WORK:

1. Winthrop University is seeking quotes from qualified and experienced companies (individually or collectively, the "Proposer") interested in providing Weightlifting Equipment for renovations to Winthrop University Ballpark Facility, (the "Work"). Details of the requested Work are attached hereto
2. Bid only as specified. No substitutions will be allowed.
3. Questions: Any prospective offeror desiring an explanation or interpretation of the solicitation, drawings, specifications, etc., must request it in writing. Questions regarding the original solicitation or any amendment must be received by the Procurement Officer by **Monday October 14, 2024 by 10:00AM EST. Questions should be submitted via email to peeplesg@winthrop.edu**
4. **Protest:** If you are aggrieved in connection with the solicitation or award of the contract, you may be entitled to protest but only as provided in Section 11-35-4210. To protest a solicitation, you must submit a protest within fifteen days of the date the applicable solicitation document is issued. To protest an award, you must (i) submit notice of your intent to protest within seven business days of the date the award notice is posted, and (ii) submit your actual protest within fifteen days of the date the award notice is posted. Days are calculated as provided in Section 11-35-310(13). Both protests and notices of intent to protest must be in writing and must be received by the appropriate Chief Procurement Officer within the time provided. See clause entitled "Protest-CPO". The grounds of the protest and the relief requested must be set forth with enough particularity to give notice of the issues to be decided. [02-2A085-2]

5. Deliveries shall be F.O.B. Destination, freight prepaid to Winthrop University. It is agreed by the parties hereto that delivery by the contractor to the common carrier does not constitute delivery to the University. Any claim for loss or damages shall be between the contractor and the carriers. All freight costs must be included in the cost of the items. Do not add a separate line for freight.
6. Unit price to be shown for each item.
7. Partial shipments will not be accepted on the specified quantity and on the specified delivery dates listed in the delivery schedule.
8. Manufacturer's standard warranty will be required in writing with the delivery of product(s).
9. DELIVERY SCHEDULE: Delivery must be made AFTER OCTOBER 28, 2024.

SPECIFICATIONS FOR WEIGHTLIFTING EQUIPMENT

I. REQUIREMENTS

- A. **SPECIFICATION:** New Weightlifting Equipment.
 - B. **WORKMANSHIP:** All workmanship shall be first class in every respect. The finished items shall be free from all avoidable imperfections of manufacture and from defects affecting the appearance or serviceability.
 - C. **WARRANTY:** The manufacturer warrants to the owner that all items furnished under these specifications will be WITH NEW MATERIALS, of good quality and workmanship, and agrees to replace promptly any units which by reason of defective materials or workmanship, shall fail under normal use, free of negligence or accident, for a minimum period of five (5) years from date of acceptance. Such replacement shall be free of any charge to the owner or his representative. Warranty applies only to the defects in material, workmanship and structure, and only to damage arising from normal usage.
- II. **ACCEPTANCE EVALUATION AND QUALITY ASSURANCE** Successful bidder will be required to furnish certification that items furnished as a result of these specifications comply with the required standards as described.
 - III. **DELIVERY AND PAYMENT:** Delivery and payment for items under this specification shall be in accordance with the terms and conditions of this solicitation. The contractor shall be responsible for any packing, packaging or protection required to insure delivery in an undamaged condition. Weightlifting equipment shall be shipped by and in a closed truck and protected from damage direct from the contractor's plant or warehouse to the University and shall be individually packaged.

ORDERING DATA: All shipments of equipment shall include the Purchase Order Number and description on the delivery ticket and invoice.
