# III. Report from the Graduate School Dean, Melissa McCartney

Quick bio: came from Queens University where she was the Dean of the Graduate School and Associate Dean for Online, so Winthrop seemed like the natural step. Before Queens she was at the University of Phoenix, before that a technical institution, and before that K-12 teacher. Currently the focus of the SGCO is working on the synergies between the three areas (graduate, online, and continuing) and working on being efficient.

Fall enrollment is very good – currently 990, up 8.3% from last fall. This is due mostly to degree-seeking with new programs like EdD, CSDV online, and MSW doing very well. Non-degree fell a little. But this enrollment increase is much higher than the national average for growth. It's not expected to continue but it's best to see a slow growth giving time to make sure they are all taken care of.

The Grad Welcome Reception was held at a new date (Tuesday instead of Thursday) and time (6pm instead of 5:30pm) which we feel had better results for those commuting from work. Current grads were also invited, as opposed to just the new, and this is something that we'll continue with as the students really enjoyed interacting with each other.

Currently working on fall events, so if there is something your area has ideas about or wants to collaborate on, reach out. Including Graduate Student Appreciation Week, and if there is any opportunity for you to include the 3MGS in your curriculums. The newest Graduate Studies Newsletter was sent and it included an event survey to try and get a better feel for how and when the students want to interact.

Recruiting – Hunter is going to 13 fairs this semester and hopefully the same amount in the spring – if there are flyers or swag or anything else that you want to include to push your program, reach out to her. Or if there are ideas for events or locations where you'd like to see your program represented. You can also join Hunter at any events – there are a few dates where we have multiple locations at the same time, and Philip and Shira are each attending one. GSO does print all the

program flyers, but feel free to stop by the office to see what we have and whether any changes need to be made.
