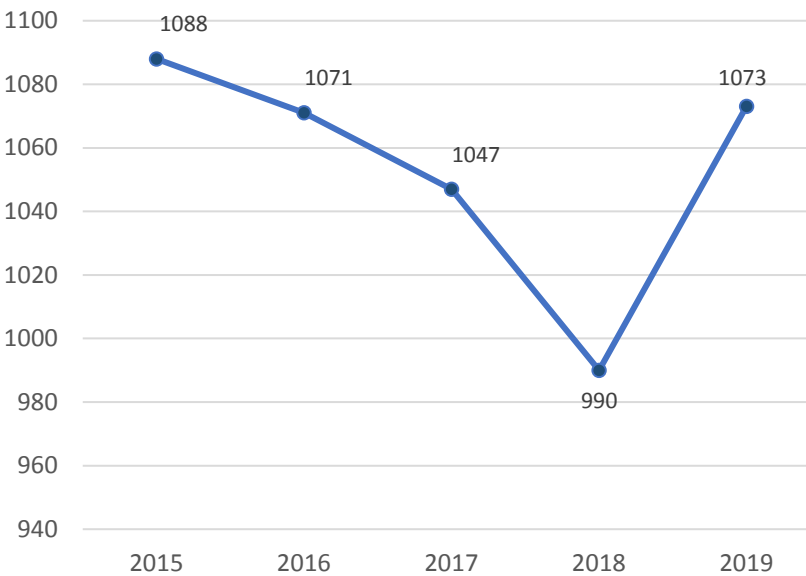

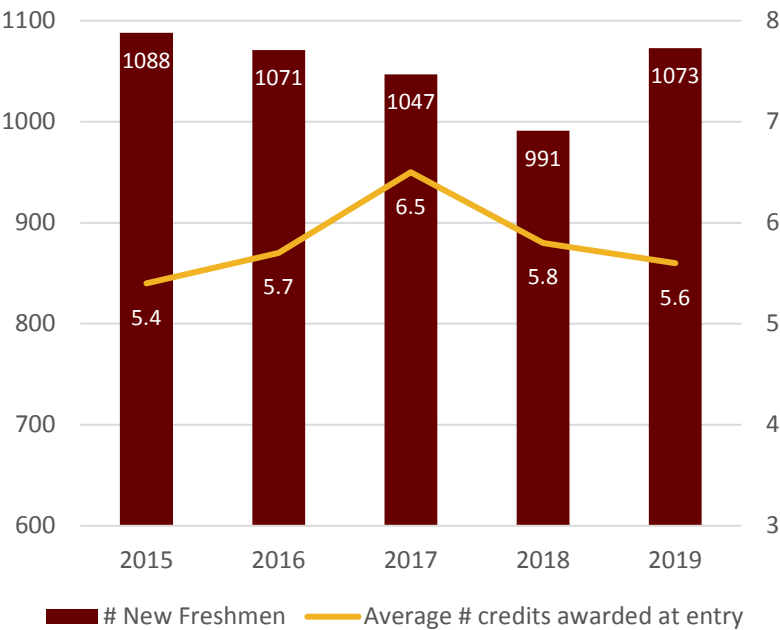
Fall Full-time and Part-time
New Freshmen and Transfer Enrollment



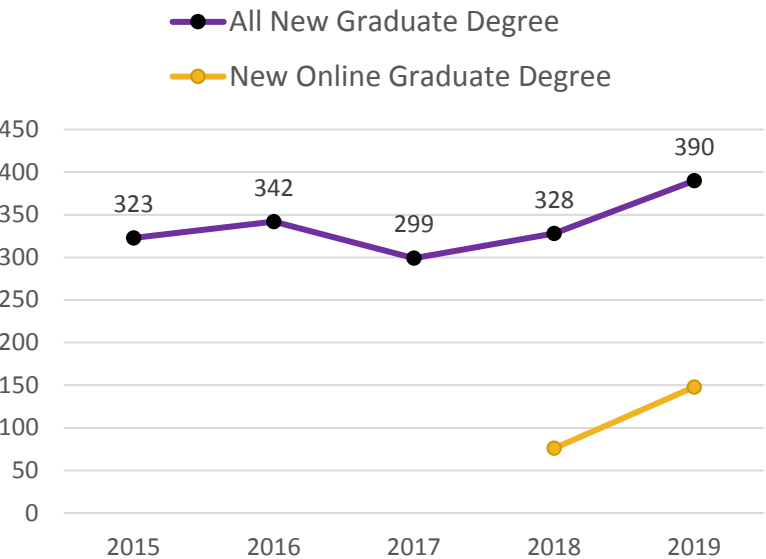
Fall First-Time Full-Time Entry
Undergraduate Cohort Headcount



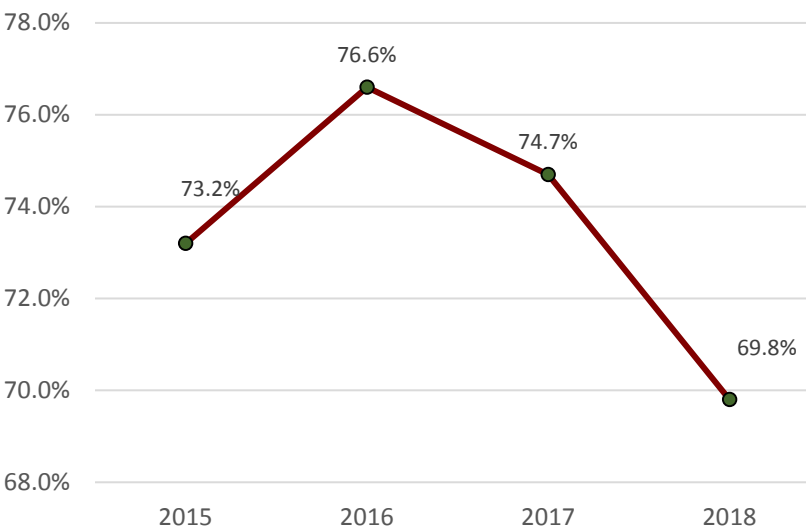
Average # Credits Awarded To Entering
Fall First-Time Freshmen



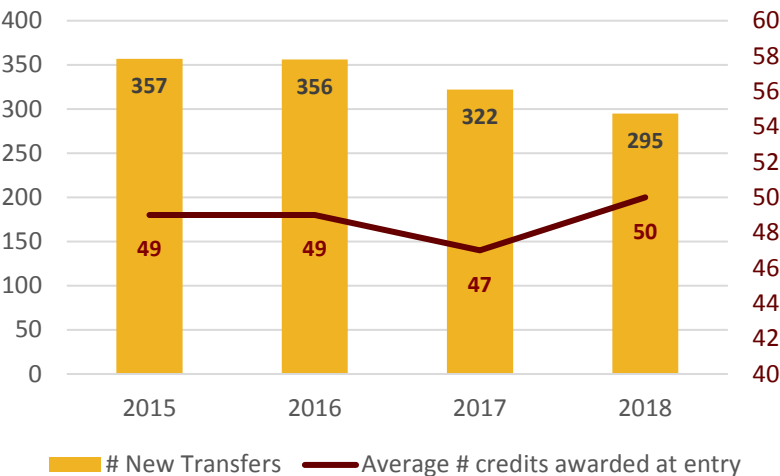

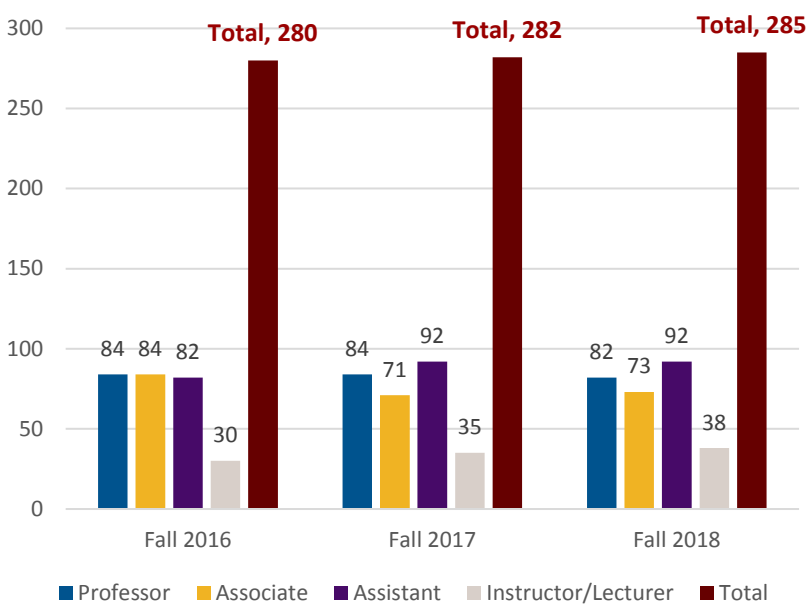

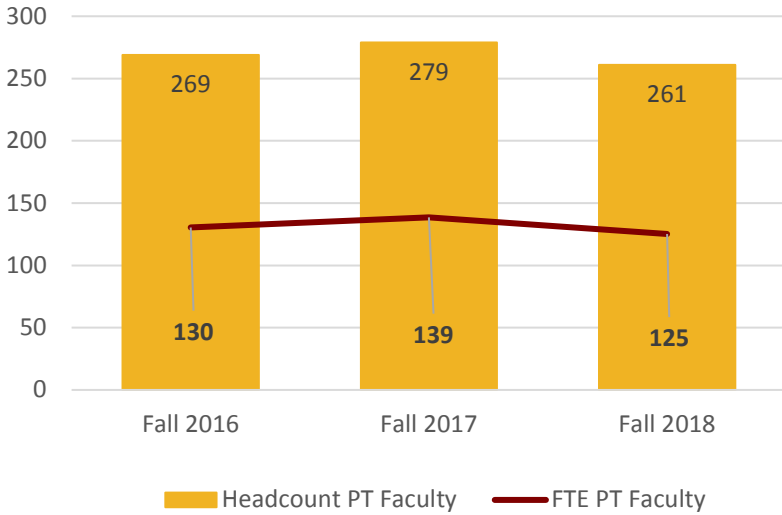
Participation in UG Research



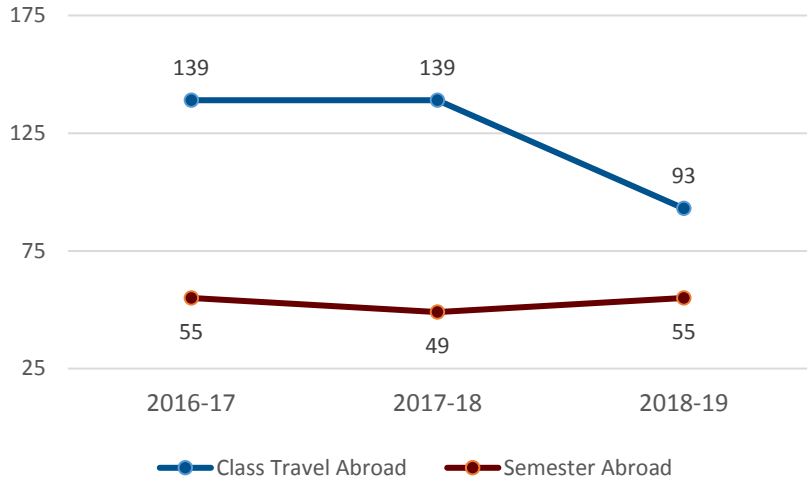
Full-time Instructional Faculty by Rank



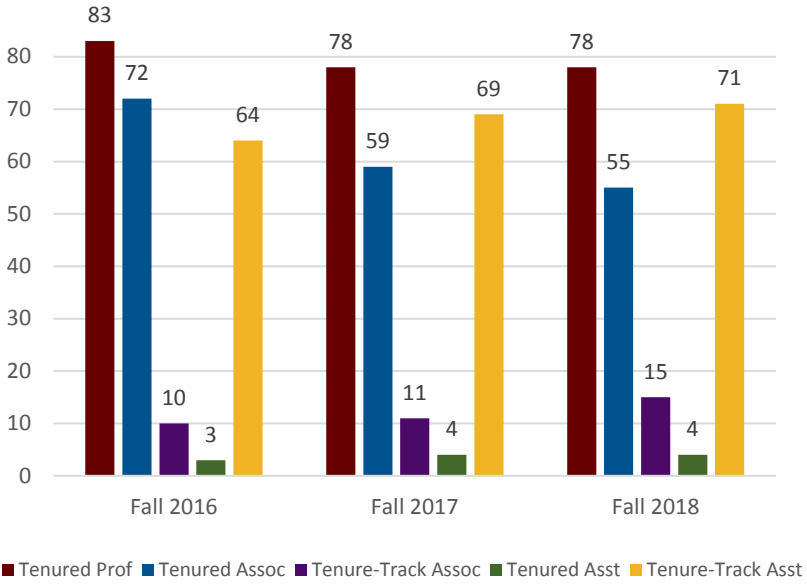
Part-Time Instructional Faculty Headcount and FTE



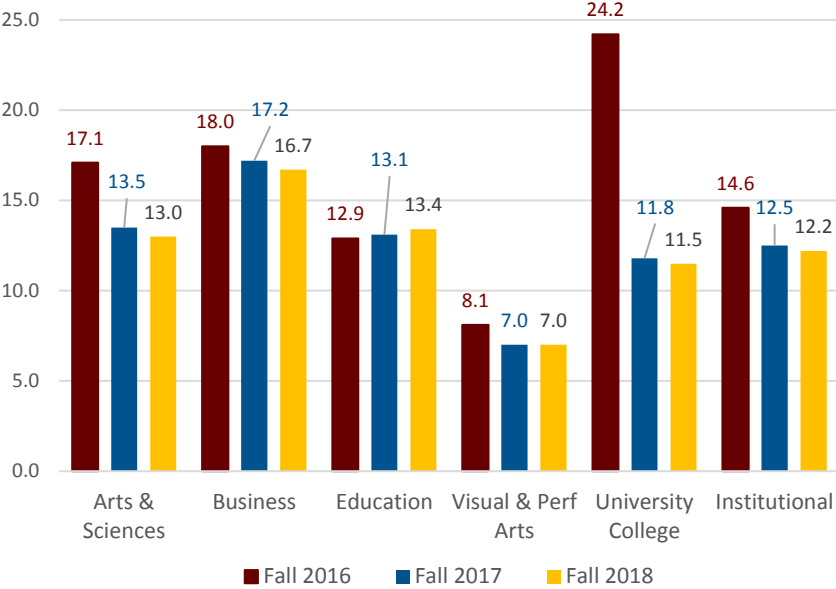
Students Completing Semester/Class Travel Abroad
